REPORT WITH REGARD TO 'RECONSTITUTION OF COMMITTEE OF CREDITORS' ALONG WITH THE LIST OF CREDITORS / CLAIMANTS, ON BEHALF OF THE INTERIM RESOLUTION PROFESSIONAL UNDER REGULATION 17 OF INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016

MOST RESPECTFULLY SHOWETH:

1. It is stated that the application for initiating corporate insolvency resolution process ("**CIRP**") filed by Ms. Pallavi Joshi Bakhru ("Financial Creditor") under section 7 of Insolvency and Bankruptcy Code, 2016 ("Code") read with rule 6 or Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016 was admitted by this Honourable Tribunal, Bench-II, New Delhi, vide its order dated 03.07.2018 and appointed the undersigned Atul Kumar Kansal as Interim Resolution Professional ("**IRP**") and was directed to take necessary actions in accordance with the relevant provisions of the Insolvency and Bankruptcy Code, 2016.
2. It is further stated that, in compliance with Regulation 17 (1) of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for corporate persons) Regulations, 2016, first report certifying the Constitution of Committee of Creditors ("**CoC**") had been filed with this Hon'ble Tribunal, Bench-II, New Delhi on 31st July 2018.
3. These claims were admitted provisionally and subject to verification from the books of accounts of Corporate Debtor as and when provided by its Suspended Directors.
4. It is pertinent to mention here that the suspended directors of the Corporate Debtor are not contactable after 16th July 2018 and / or there is neither any communication from them either over email or in response to my email nor their phone numbers or whatsapp numbers is working. IRP made various efforts to contact the suspended directors in all possible manner but all efforts

failed as these suspended directors, Mr. Raman Puri, Mr. Vikram Puri and Varun Puri are completely non-contactable and are not cooperating with the IRP. Therefore, the suspended directors failed to handover the charge of the affairs of the Corporate Debtor including all its records and documents and status of the assets / projects of the Corporate Debtor.

5. Due to this non-cooperation of the suspended directors of the Corporate Debtor, the IRP is unable to check and verify the status of projects including details of ownership, necessary approvals and permissions, status of sold and unsold area, status of transfer of possession and / or conveyance of the property sold to the homebuyers / real estate allottee(s) amongst other.
6. Even after the last date of receiving claims as per public announcement dated 7th July 2018, creditors continued to file their claims and in the process IRP has received 217 more claims.
7. Further, on the basis of further information received from the creditors, amount of claim admitted has also undergone change and now there are total 723 number of class of creditors and 10 number of financial creditors as detailed in Annexure-A of this report.
8. That in addition to this, there are 26 claimants whose claims are defective and IRP has advised such claimants to file their application with proper details and documents, the details of which are marked and annexed herewith as Annexure-5 of this report.
9. Now after taking into consideration the additional claims, the CoC is reconstituted as per Annexure-A and according to which 63.05% CoC members are from 'class of creditors' and remaining 36.95% are financial creditors.
10. In light of the facts and circumstances, the undersigned herein is filing the present report with the amended and updated list of financial creditors and class of creditors under Regulation (13) (2) (d) of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for corporate persons) Regulations, 2016 by CA Mr. Atul Kumar Kansal, IRP under the Insolvency & Bankruptcy Code, 2016.

REPORT CERTIFYING THE CONSTITUTION OF COMMITTEE OF CREDITORS

1. The application for initiating corporate insolvency resolution process ("CIRP") filed by Ms. Pallavi Joshi Bakhru ("Financial Creditor") under section 7 of Insolvency and Bankruptcy Code, 2016 ("Code") read with rule 6 of Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016 was admitted by this Honourable Tribunal Bench-II vide its order dated 03.07.2018 wherein this Hon'ble Tribunal Bench-II was pleased to appoint the undersigned Atul Kumar Kansal as Interim Resolution Professional ("IRP") and was directed to take necessary actions in accordance with the relevant provisions of the Insolvency and Bankruptcy Code, 2016.
2. In compliance with Section 13, Section 15 and other applicable sections of the Code read with regulation 6 of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process of Corporate Persons) Regulations 2016 (hereinafter called "Regulations"), a public announcement;
 - i. Intimating the commencement of Corporate Insolvency Resolution Process against M/s Universal Buildwell Private Limited [**Corporate Debtor**];
 - ii. Calling the creditors of M/s Universal Buildwell Private Limited, the Corporate Debtor herein to submit their claims along with the proof of such claims.

The Public announcement was published in newspapers in Hindi edition of '**Jansatta**' and English Edition of '**Indian Express**' on 07.07.2018 and according to this advertisement, the last for submissions of claim was 18.7.2018.
3. The said public announcement sought submission of claims by financial creditors, operational creditors, employees and workmen and other creditors of the Corporate Debtor along with the proof of such claims.

11. In terms of the said publication / advertisement, 591 claims were received from all financial creditors, operational creditors, homebuyers employees and workmen and other creditors until 18.7.2018, the details of which were submitted before this Hon'ble Tribunal, Bench-II on 31st July 2018.
12. Further, more claims were received even after last date of filing claims as per public announcement. Till 15.09.2018, IRP had received 809 claims from all financial creditors, operational creditors, homebuyer's employees and workmen and other creditors, the details of which are mentioned hereinafter in this report. List of such claims are marked and annexed herewith as **Annexure-1** (List of financial creditors), **Annexure-1A** (List of allottee under Real Estate Project), **Annexure-2** (List of Operational creditors), **Annexure-3** (List of workmen and employees), and **Annexure 4** (Other creditors). Further, claims received in defective/wrong forms have also been marked and annexed as **Annexure-5**.
13. Also, on the basis of further information received from the creditors, amount of claim admitted has also undergone change.
14. For constitution of Committee of Creditors ("**CoC**"), the following provisions may please be looked into:-

Quote:

Section 21(1). The interim resolution professional shall after collation of all claims received against the corporate debtor, constitute a committee of creditors.

(2). The committee of creditors shall comprise all the financial creditors of the debtor.

Unquote:

The above section of the Code is to be read with regulations 12(2) and 12(3) which states:

Quote:

(1) Subject to sub-regulation (2), a creditor shall submit proof of claim on or before the last date mentioned in the public announcement.

(2) A creditor, who failed to submit proof of claim within the time stipulated in the public announcement, may submit such proof to the interim resolution

professional or the resolution professional, as the case may be, on or before the ninetieth day of insolvency commencement date.

(3) Where the creditor is sub-regulation (2) is a financial creditor under regulation 8, it shall be included in the committee from date of admission of such claim:

Provided that such inclusion shall not affect the validity of any decision taken by the committee prior to such inclusion.

12. For determination of amount of claim, the following provisions may please be looked into:-

Quote:

Regulation 14:

(1) Where the amount claimed by a creditor is not precise due to any contingency or other reason, the interim resolution professional or the resolution professional, as the case may be, shall make the best estimate of the amount of the claim based on the information available with him.

(2). The interim resolution professional or the resolution professional, as the case may be, shall revise the amounts of claims admitted, including the estimates of claims made under sub-regulation (1), as soon as may be practicable, when he comes across additional information warranting such revision.
